Much of my practice centers around twice exceptional children; gifted children who also have a diagnosis of Autism Spectrum Disorder, ADHD, learning disabilities, social challenges and/or anxiety.

Some may have a dual diagnosis such as Autism or ADHD, and many others have behavioral or emotional challenges that can worsen under stress. In a comfortable and supportive atmosphere, I offer a highly personalized approach that is tailored to a client's individual needs. A focus on personal growth honors a child's unique experiences and challenges. In addition, I am the parent of two twice-exceptional children.

Briefly state how your understanding of the needs of gifted/2e individuals and families inform your approach?

In my work with gifted and 2e individuals, I make a point of keeping therapy intellectually stimulating while working on their areas of weakness. Gifted individuals find purpose in our sessions and remain committed when they are constantly engaged in the process. I take time every session to ensure that my clients continue to see the "why" of therapy. I love working with this population because they keep me on my toes!
